**Here is an overview of the various programs that we offer. I will be glad to go over these in more detail with you, but they are mostly self-explanatory. Also, please keep in mind that these are programs that we can offer, however, they are subject to approval. Not all of our programs offer all of these options.**

- 1. 6x99, which means it's \$198 down plus standard documentation fee and \$99 a month for the first 6 payments**
- 2. \$0 down**
- 3. 1 payment down (standard is 2 payments down)**
- 4. 60 Day Deferral on payments**
- 5. 90 Day Deferral on payments**
- 6. Seasonal Skip, which means the customer can skip any 3 months' payments during the year, however, the 3 months need to be decided up front and don't change**
- 7. Annual payments**
- 8. Semi-annual payments**
- 9. Quarterly payments**
- 10. Working capital program**
- 11. Refinancing, which we can tie a new lease into.**
- 12. Soft costs**
  - a. can be anywhere from 20-35% of overall sale**
  - b. anything that's not normally covered, ie. Warranty and service programs, software, or anything else than can be thought of**

**This covers most things, but there are some programs that aren't common that are deal specific.**
